A Meeting of Great & Little Plumstead Parish Council was held on Monday 12th February 2024 at 7.00pm at Great Plumstead Village Hall

• Police Report – Thorpe End – 1, Little Plumstead – 2, Great Plumstead - 2

County Councillor Report – Norfolk County Council were able to remove some changes to services due to additional funding from the Government, however this is a one off funding and only goes so far to closing the considerable gap in the council's finances for 2024/25. A balanced budget has been agreed by the senior finance and will be presented on Tuesday 20th February. The Council will still be spending more on its core statutory duties regarding adult care and child care than in 23/24. The Council have been able to invest in new recycling centres, library services, fire and rescue equipment and estate as well as highway repairs. Norfolk is now ranked second out of all county councils for its road maintenance. The Council has also been able to use government funding to start new and later bus routes. More information about the budget can be found on the Norfolk County Council website. Councillor Mackie will be chairing the Audit and Governance Committee. one area of our work is regarding anti-fraud policies and processes. Councillor Mackie's Highways and Environment Grant is available from April 2024 and the Parish Council are welcomed to put forward ideas. Councillor Bullen has already contacted to enquire about additional pathways from the Broadland Business Park, which Councillor Mackie has taken to Highways. Additional drainage works have been requested on Broad Lane in Little Plumstead which Highways are dealing with. Highways are also dealing with larger drainage works on Hospital Road, Little Plumstead. From the 1st February 2024 all Norfolk residents who hold a disabled concessionary travel pass will be eligible for free bus travel 24 hours a day, 7 days a week when travelling within the county. Norfolk County Council and the Royal Norfolk Agricultural Association have joined forces to launch a new Norfolk Rural Business Awards. The awards will be launched on 6th February at the annual Norfolk Farming Conference and are designed to recognise the essential nature and huge important of Norfolk's rural communities and businesses to the region. The entry form for nominations to each category he found online can at The entry deadline is 19th April 2024. www.norfolk.gov.uk/norfolkruralbusinessawards. Judging will include a visit to all shortlisted business and each finalist will be asked to participate in a short film. The Councillors reported that the hedge cutting along Hospital Road, Little Plumstead was not cut well and a large amount of cuttings were left on the pathway. This causes huge issues with pedestrians as the thorns a large and get into

- bike/pram wheels and also stick into dogs feet. This has been reported back to the Rangers/Highways already but will be chased up.
- District Councillor Report The funding roll-over for the medical centre was confirmed in January after it had to be applied for again from the DHSC for the 2024/25 financial year. The hydraulic modelling report for the site was delayed and Councillor Harvey is awaiting an update on this and the Saffron Homes detailed proposal to submit for served matters approval. Both the NHS and Saffron Homes were aiming to start construction in the "Summer" however Councillor Harvey is waiting for confirmation of a more detailed plan, and am continuing to push to bring the date of the foot/cycle path forward. There is still a small amount of Winter Pressures grant funding available for Broadland residents. Funding is for a maximum of £1500 per group and can be used for projects such as supporting warm spaces, providing hampers/gifts for vulnerable households, purchasing warmth providing equipment for those in need. Projects need to be engaged with other local support and the Help Hub and need to be delivered by March 2024. For more information and an application form can be found on the Broadland District Council website. BDC has a new Help Hub outreach vehicle which is initially going out to visit designed Warm Spaces in the district and will alter be going out to other settings where Help Hub support could be useful. Advice on benefits, debt welfare, isolation, anti-social behaviour and domestic abuse will be available. A feedback report on progress made has been received from the Local Government Association Corporate Peer Challenge Team which visited the Council for a second time on 13th October 2023. Good progress has been made by the Council following the initial visit made in July 2022. Councillor Harvey's Ward Grant has been allocated for the purchase of a replacement shed for Friends of Little Plumstead School, for equipment storage to allow them to carry on their activities. The government has provided £9.6m funding assistance for the Nutrient mitigation in Norfolk. Norfolk Environment Credits Ltd will start trading in a few weeks' time. Work is ongoing to produce the Broadland District Council Plan for 2024-2028. The plan identifies key priorities, aims and activities for the new 4 years and will be adopted in the Spring. This is supported by a separate document called the Delivery Plan, which gives more detail on the planned programme of work for 2024-26. The finalists for the BDC Business Awards have been announced and the awards ceremony will be on 5th March 2024 at Norwich City Football Club, details can be found on the Broadland DC website. BDC received funding in 2022 from the government Rural England Prosperity Fund. Up to £50,000 will be allocated to create a content creation kitchen at the Food Innovation Centre. The remaining funds have been allocated to the Rural Business Builder programme to provide grants of up to £25,000 for eligible businesses. The Broadland Community Tree Planting Grant Scheme is still available for this tree planting season up to March 2024. It is open for community groups, town and parish councils and charities to plant trees in Broadland. Funding can cover the cost of trees, planting, fencing and guards for protection, as well as aftercare to ensure the trees have the best chance of survival. Grants of up to £1000 per application area available. The Business Regulatory support hub service has been reviewed. This provides licensing and regulatory advice and support for local businesses. Uptake of the service has increased over time and businesses report strong satisfaction with the service. A review has been undertaken of an Anti-Social Behaviour pilot service run by the council. increased focus on early intervention has been successful in ensuring the council has resolved cases effectively and efficiently and promoted community safety. Demand on the service has been increasing, with complaints commonly relating to neighbour noise, fly tipping and waste-related behaviour and noise from commercial premises. The land behind

Astley Road, Little Plumstead which is owned by Flatlands has been reported to Broadland District Council to see what pressure can be put onto the landowner to maintain the trees.

• Public Participation – The parishioners reported that there is a serious littering issue on Broad Lane, Little Plumstead. The Councillors asked whether the parishioners would be willing to be put together a litter pick, similar to what happens in Thorpe End. The parishioners questioned what is happening to the rubbish which was left by the travellers on Thorpe End Drive, it was confirmed that this would fall to Norfolk County Council and will be reported to them. There is a speeding issue on Broad Lane, Little Plumstead coming towards the junction with Norwich Road. Parishioners were asked whether they would be interested in setting up a Community Speed Watch scheme, which needs a minimum of 3 members. The Parish Council will look into whether the SAM2 sign can be placed there and will need Highways permission first. Councillor Bullen questioned whether signage could be installed on Broad Lane to bring speed awareness to the motorists. It was discussed that there is a flooding issue on Hospital Road (close to the entrance to the Octagon) but the water did not seem to be flowing to the pond on the otherside of the hedge, this will be reported to Highways for this to be investigated.

This is now declared "completely unviable" and it is suggested that 4 additional sites be added to raise the number to 11 and the certified "Passivhaus" requirement be removed. (The numbering and plot changes from the original are confusing in the documentation. It is assumed the 10 house reference is because 1 property is already constructed). The objection is raised primarily because of the loss of passivhaus certification, although encouragement is given to "get as close as possible", as this was a primary reason for the permission being granted. It is recognised that this requirement is not easy to achieve and adds costs to the property but removal of a primary reason for consent is not a good precedent. The other primary reason for objection is that the design and access statement notes that the scale and massing 'have a domestic scale and rectilinear floor plan' with massing as two storey broken by single storey elements. The argument is provided that the 11 (10), will be smaller in scale than originally intended for the 7 to make them more accessible in terms of cost and build, yet this is completely offset by the provided proposals for Plot 8 with floor plan dimensions exceeding 20 plus metres all round and appearing disproportionately large on the development site. The Parish Council believes that this is an overdevelopment of the site

David Bullen Limited has produced plans which the bowls club, scouts and committee are happy with. The changing rooms will come into the field approximately 10m, Councillor Heath confirmed that this will still allow the football activities to take place. The Scouts were happy that the parade square was being retained but were concerned with the loss of area between the Scout Hut and the new activity building but with the plan of making this hard standing it would mean the area becomes all weather. Councillor Wiley thanked the group for all their hard work. The Councillors were happy to go to planning and to complete the planning application. The Clerk will get quotes for the leases for the new buildings. Proposed – Councillor Edwards. Seconded – Councillor Cawdron. All agreed.
