# A Meeting of Great & Little Plumstead Parish Council was held on Monday 11<sup>th</sup> April 2022 at 7.00pm at St David's, Thorpe End

- **Police Report** Thorpe End 1, Little Plumstead 7, Great Plumstead 3
- County Councillor Report The County Council has various teams to support across the county and more details on Homes for Ukraine and much more can be found on the Norfolk County Council's website. Beryl Bikes have now been launched in Dussindale and Councillor Mackie is interested to know how the residents of Thorpe End welcome the idea of the Bikes in the village? Little Plumstead Primary School is shortly to take a delivery of reconditioned laptops from the County Council. The County Council working in partnership with others has been awarded a further £3m to support rural businesses with capital grants of between £5k £300k. Planning across the County to celebrate the Queen's Platinum Jubilee. Thorpe Town Council have a music event and beacon lighting on the Thursday evening. Thorpe Parish Church have a Big Lunch on Sunday 5<sup>th</sup> June. The Councillors asked Councillor Mackie to help push the white gate project with Highways as the Parish Council are still waiting for the final price for these. A parishioner asked Councillor Mackie to see what can be done about the state of the path on Post Office Road, Little Plumstead, Councillor Mackie confirmed this will be passed to Mr Pearson of Highways for inspection.
- District Councillor Report Natural England and DEFFRA on the 16<sup>th</sup> March 2022 have issued notice in Norfolk to the findings of the state of rivers and the Broads. As a result, all Norfolk Planning Authorities are now required to ensure that any planning permission granted for "over-night" accommodation can demonstrate it has a neutral or better impact on the nutrients it will produce. At this time there is no measures or ability to demonstrate this which may delay planning applications being determined. A number of events are happening in Broadland to celebrate the Queen's Platinum Jubilee 2 June Thorpe Lodge Raising the Flag, 4 June Blickling Hall Party in the Park, Summer holidays various sites across Broadland Jubilee Treasure Hunt. New kerbside collection service has started with an aim to reduce waste and increase recycling. Small electrical items, batteries and textiles will be collected each week alongside your rubbish and recycling bins for collection. All items should be grouped into electrical, batteries or textile items.
- **Public Participation** Sam Curtis attended the meeting to provide information on her hopes for leasing part of the woodland in Little Plumstead. Ms Curtis was involved in the Colney Woodland Burial and is looking into providing something with the same ethos in the

woodland in Little Plumstead. Ms Curtis is looking to take a 99 year lease from Flatlands and is currently at the pre-planning stage (nothing has been submitted to Broadland DC). The area which is being discussed is at the back of the woodland, on the other side of the lake from the houses. It was confirmed that the only buildings which would be put on the land would be toilet and washing facilities together with a carpark area, these are proposed to go in the clearing just inside the gates off Witton Lane. Access at the moment is still an issue as Mr Edwards does not own the access strip.
